

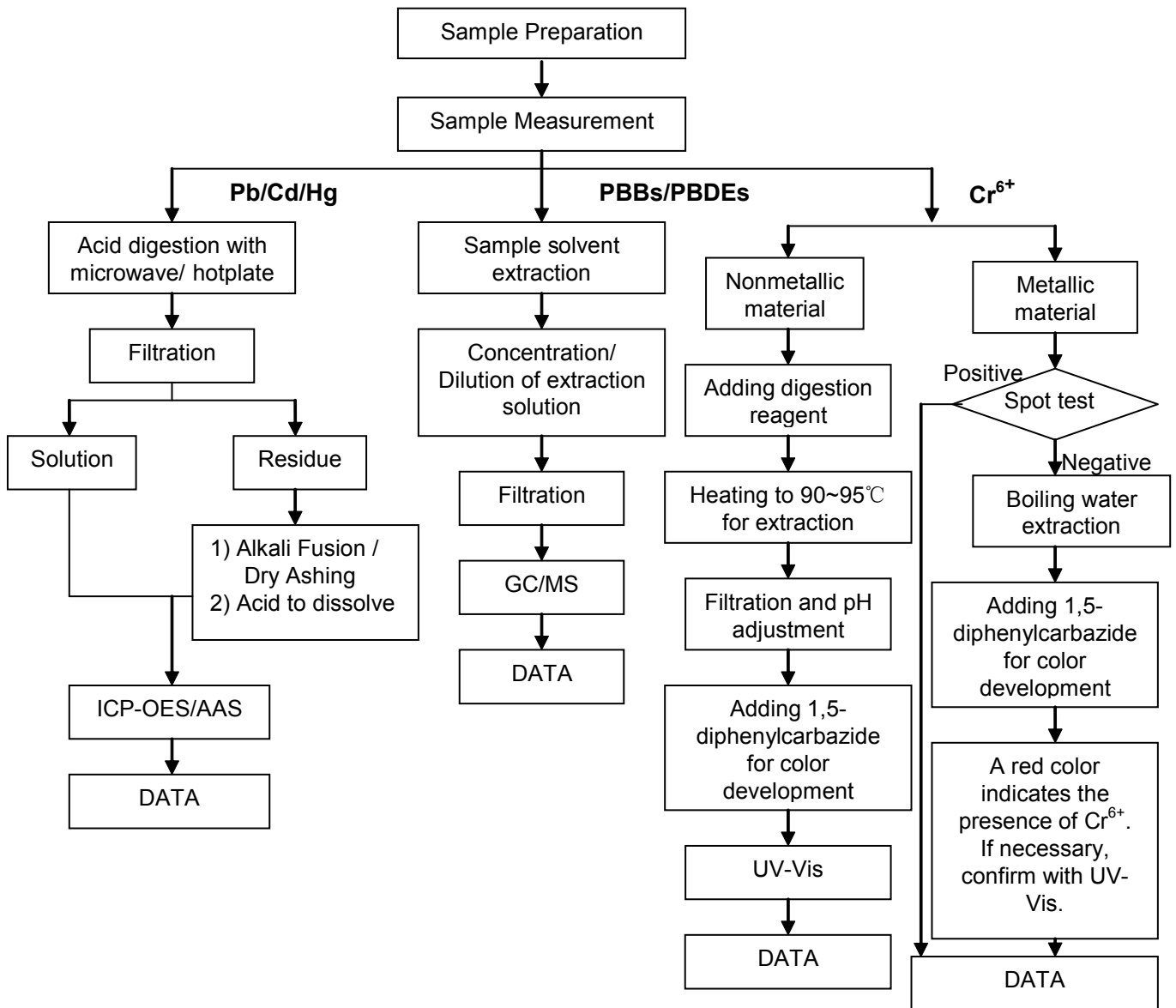

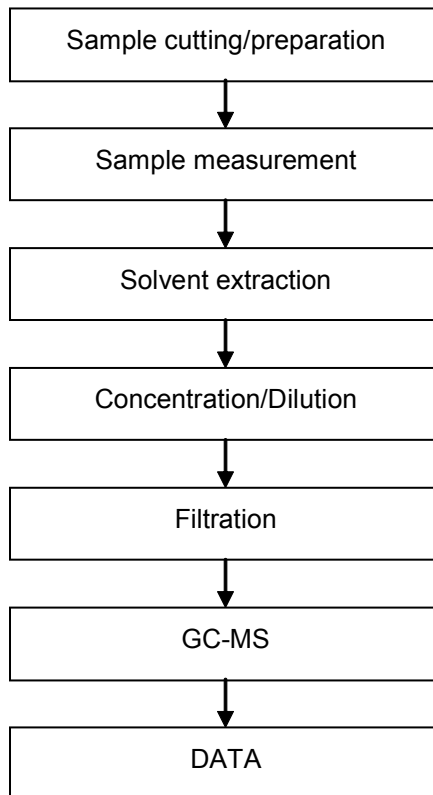

Phthalates Testing Flow Chart

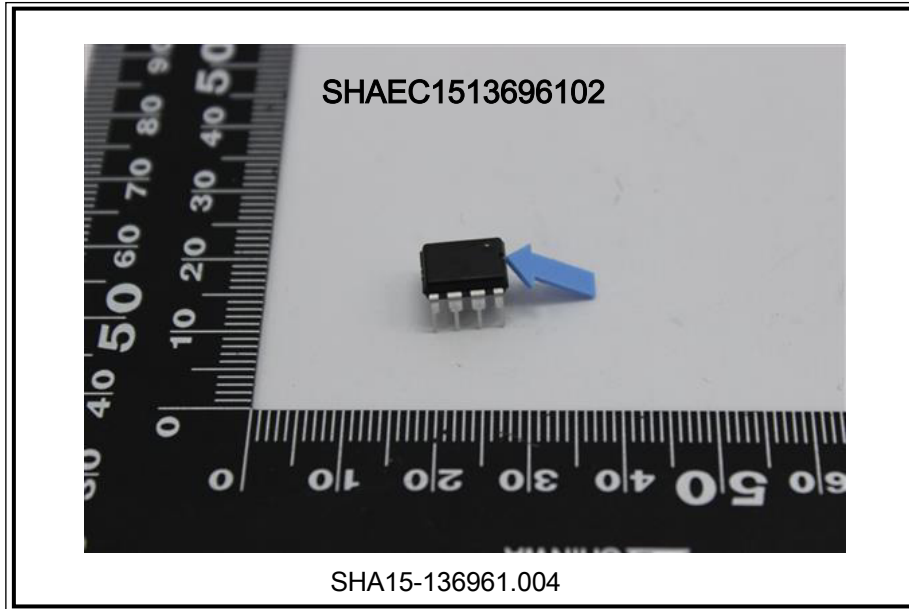
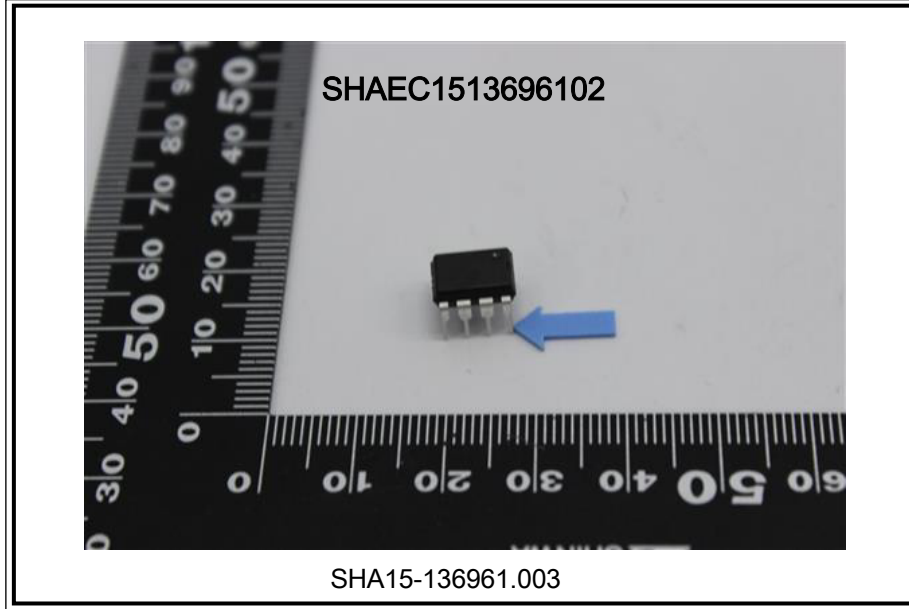
